



On approval of the Rules for the appointment, payment and amount of state scholarships

In order to implement paragraph 7 of Article 47 of the Law of the Republic of Kazakhstan "On Education", the Government of the Republic of Kazakhstan **DECIDES:**

1. To approve the attached Rules for the appointment, payment and amount of state scholarships for students in educational institutions.

2. Recognize as invalid some decisions of the Government of the Republic of Kazakhstan in accordance with the annex to this resolution.

Rules for the appointment, payment and size of state scholarships

Chapter 1. General Provisions

1. These Rules for the appointment, payment and size of state scholarships (hereinafter referred to as the Rules) are developed in accordance with the Law of the Republic of Kazakhstan "On Education" (hereinafter referred to as the Law) and determine the procedure for the appointment and payment, as well as the size of state scholarships.

2. State scholarships are assigned and paid to students, interns, undergraduates, doctoral students, resident doctors, students of preparatory departments of organizations of higher and (or) postgraduate education, studying in educational organizations under the state educational order for full-time education (hereinafter referred to as recipients).

3. These Rules do not apply to the procedure for the appointment and payment of scholarships established by the President of the Republic of Kazakhstan, as well as state nominal scholarships established by the Government of the Republic of Kazakhstan

4. The procedure for assigning and paying scholarships to students, undergraduates, doctoral students, resident doctors, students of the preparatory departments of the autonomous educational organization "Nazarbayev University" is determined in accordance with the Law of the Republic of Kazakhstan "On the status of "Nazarbayev University", "Nazarbayev Intellectual Schools" and "Nazarbayev Fund".

Chapter 2. Procedure for awarding state scholarships

5. The state scholarship is awarded to students, interns, undergraduates studying under the state educational order, as well as students, interns, undergraduates transferred to study under the state educational order, who received, based on the results of the intermediate attestation (examination session), the equivalent of grades corresponding to the grades "excellent" , "Fine".

6. For doctoral students, resident doctors and students of preparatory departments, a state scholarship is assigned for the entire period of study, regardless of the results of the intermediate attestation (examination session) during the entire period of study.

7. The state scholarship for the first academic period is assigned to all students, undergraduates enrolled in the first year (first year of study) under the state educational order, from September 1 or January 1 until the end of the first academic period and holidays inclusive until the end of the month in which the academic year ends. period and holidays.

In subsequent academic periods, the state scholarship is awarded to students, undergraduates based on the results of intermediate certification (examination session) for the previous academic period in accordance with paragraph 5 of these Rules.

8. Students, interns, undergraduates who did not pass the intermediate attestation (examination session) within the time limits determined by the academic calendar, for good reasons (illness, family circumstances, natural disasters, training for academic or

credit mobility), the management of the educational organization after presentation to students supporting documents, individual deadlines for passing the intermediate certification (examination session) are established.

Based on the results of the passed intermediate certification (examination session), this category of students is assigned a state scholarship in the manner prescribed by these Rules.

9. For students, interns, undergraduates transferred from one educational institution to another, a state scholarship is assigned in the manner prescribed by these Rules, based on the results of the previous semester.

10. For students, interns, undergraduates who have returned from academic leave, the appointment of a state scholarship is carried out in the manner prescribed by these Rules, after the elimination of the academic difference in the curricula.

Students, interns, undergraduates left for a second year of study due to illness, from the moment they return, a state scholarship is assigned in the manner prescribed by these Rules, based on the results of the previous semester in which the curriculum was completed.

Students, interns, undergraduates, resident doctors, doctoral students, patients with tuberculosis, in the presence of an appropriate medical certificate, are awarded a state scholarship for the period of incapacity for work, but not more than ten months from the date of incapacity for work, regardless of the results of the previous semester.

11. During the period when students, interns, undergraduates, doctoral students, resident doctors are on parental leave until they reach the age of three years, the state scholarship is not assigned.

12. The appointment of state scholarships is made by order of the head of the educational organization or a person replacing him, on the basis of a memo (representation) of the head of the unit, which is entrusted with monitoring the progress of students.

13. The appointment of state scholarships is terminated:

1) in case of expulsion (expulsion) of a student from an educational organization, regardless of the reasons for expulsion (exclusion);

2) in case of death of a student;

3) after completion of studies by students from the date of issuance of the graduation order.

14. Termination of the appointment of state scholarships in cases specified in paragraph 13 of these Rules is carried out by issuing an appropriate order of the head of the educational organization or the person replacing him.

15. The state scholarship for persons with visual and hearing disabilities, orphans and children left without parental care and under guardianship (guardianship), studying under the state educational order, is assigned taking into account the increase, from the date of submission of supporting documents and in the absence of academic debt based on the results of the examination session.

Chapter 3. The procedure for paying state scholarships

16. State scholarship is paid on the basis of the order on its appointment, provided for in paragraph 12 of these Rules.

The payment of state scholarships is carried out (according to paragraph 13-1 of Article 1 of the Law of the Republic of Kazakhstan "On Education") by the operator of the authorized body in the field of education - a legal entity with a wholly owned state participation in the authorized capital, determined by the authorized body in the field of education, placing a state order for providing students, undergraduates and doctoral students in places in hostels, the state educational order for secondary education in private educational institutions, the state educational order for the training of personnel with higher and postgraduate education and the payment of state scholarships, with the exception of state nominal scholarships, as well as coordinating the activities of participants in the per capita regulatory financing within the limits provided for by the legislation of the Republic of Kazakhstan, and ensuring monitoring and control over the observance by the persons specified in paragraph 17 of Article 47 of the Law of their obligations to work off or reimburse expenses of budgetary funds in case of non-working out (hereinafter referred to as the operator): within the framework of the relevant budget programs, the administrator of which is the authorized body in the field of education; as agreed, within the framework of the relevant budget programs, the administrators of which are other authorized bodies of the relevant industry.

17. Payments of state scholarships are made for a full month, without splitting, after checking the compliance of recipients with the requirements of these Rules, carried out as of the 15th day of the month, with the exception of recipients studying in the first semester of the first year, whose compliance check is carried out in September as of 30 September, and in subsequent months as of the 15th day of the month to establish the facts specified in paragraph 13 of these Rules.

18. As part of the payment of state scholarships, the operator determines an information system through which interaction with organizations of higher and (or) postgraduate education is carried out.

Organizations of higher and (or) postgraduate education provide the operator with information about the recipients studying with them, the results of their intermediate certification (examination session), the categories of recipients in accordance with

these Rules, as well as the details of their current accounts opened with a second-tier bank or the National Postal Operator of their choice recipients.

19. Payments of state scholarships are made by crediting their amounts to a current account opened with a second-tier bank or the National Postal Operator at the choice of recipients.

20. The state scholarship is paid monthly from the first day of the month following the intermediate certification (examination session) and holidays, inclusive until the end of the month in which the academic period, intermediate certification and holidays end. For graduate students, the state scholarship is paid for the period before the date of deduction in connection with the end of educational organizations.

21. Persons with visual and hearing disabilities, orphans and children left without parental care and under guardianship (guardianship), studying under the state educational order, the state scholarship is paid taking into account the increase, from the date of submission of supporting documents and in the absence of academic debt based on the results of the examination session.

22. Students, interns, undergraduates, presented on a state scholarship, the state scholarship for the period of summer holidays is paid in total for two months (July, August).

23. During the period of professional practice, summer holidays, as well as during the period of work at workplaces and in positions with the payment of wages to students, interns, undergraduates, the state scholarship is paid in the manner prescribed by paragraph 12 of these Rules.

24. During the period when students, interns, undergraduates, resident doctors, doctoral students are on academic leave, the state scholarship is not paid, with the exception of academic holidays granted on the basis of a medical opinion (conclusion of the medical advisory commission).

25. For students, interns, undergraduates, resident doctors, doctoral students for the period of maternity leave, the state scholarship is paid in the amount established before going on maternity leave, for the entire period established by the current legislation of the Republic of Kazakhstan.

When submitting a certificate of temporary disability due to pregnancy and childbirth during academic leave, academic leave is interrupted and maternity leave is issued.

Chapter 4

26. For students under the state educational order, the amount of the monthly state scholarship is established:

1) students studying in educational organizations implementing educational programs of higher education, with the exception of students studying in pedagogical areas of

training and the direction "Health", - 36660 (thirty six thousand six hundred sixty) tenge;

2) students studying in pedagogical areas of training in educational organizations implementing educational programs of higher education - 58800 (fifty eight thousand eight hundred) tenge;

3) students studying in the direction of training "Healthcare" in educational organizations implementing educational programs of higher education - 58800 (fifty eight thousand eight hundred) tenge;

4) interns - 66403 (sixty-six thousand four hundred and three) tenge;

5) undergraduates - 86987 (eighty-six thousand nine hundred eighty-seven) tenge;

6) undergraduates studying at the autonomous organization of education "Nazarbayev University" - 162500 (one hundred and sixty-two thousand five hundred) tenge;

7) doctoral students - 195,000 (one hundred ninety-five thousand) tenge;

8) doctoral students in the field of study "Healthcare" - 195,000 (one hundred ninety-five thousand) tenge;

9) resident doctors and undergraduates in the direction of training "Health" - 100036 (one hundred thousand thirty-six) tenge;

10) for undergraduates of the Academy of Justice under the Supreme Court of the Republic of Kazakhstan, sent to study from state bodies - at the level of the official salary at the last place of work, but not lower than the amount of the state scholarship established for undergraduates studying under the state educational order;

11) students studying in educational organizations implementing educational programs of technical and vocational education for working qualifications - 21787 (twenty one thousand seven hundred eighty seven) tenge.

27. State scholarship for students studying in educational organizations implementing educational programs of technical and professional (providing for the training of mid-level specialists), post-secondary education - 20948 (twenty thousand nine hundred forty-eight) tenge.

28. For students of preparatory departments of organizations of higher and (or) postgraduate education, the amount of the state scholarship is set at the level of 85 (eighty-five) percent of the monthly state scholarship of students studying in educational organizations implementing educational programs of higher education specified in subparagraph 1) of paragraph 25 of these Rules.

29. Persons with visual impairments and persons with hearing impairments, orphans and children left without parental care and under guardianship (guardianship), as well as students and undergraduates who have only "excellent", have the right to receive an increased state scholarship during the period of study in educational organizations.

The increase in the size of the state scholarship is established in accordance with the appendix to these Rules.

30. In accordance with the Law of the Republic of Kazakhstan "On the Social Protection of Citizens Affected by an Environmental Disaster in the Aral Sea Region", students living in an environmental disaster zone are paid a scholarship using a coefficient for living in environmentally unfavorable conditions.

31. For students and undergraduates who, in accordance with the legislation of the Republic of Kazakhstan, are fully supported by the state, the state scholarship is established in the amount of 50 (fifty) percent of the state scholarship, respectively, for students and undergraduates.

32. For students, interns, undergraduates, doctoral students, resident doctors who are on academic leave on the basis of a medical certificate, for the period of academic leave, the state scholarship is set at 50 (fifty) percent (for persons with disabilities - 75 (seventy-five) percent), accordingly, on the size of the state scholarship for doctoral students, resident doctors, students, interns, undergraduates.
