Rules for the appointment of scholarships established by the President of the Republic of Kazakhstan

1. These Rules for the appointment of scholarships established by the President of the Republic of Kazakhstan (hereinafter referred to as the Rules) are developed in accordance with paragraph 6 of the Decree of the President of the Republic of Kazakhstan dated March 5, 1993 No. 1134 "On the establishment of a scholarship of the President of the Republic of Kazakhstan" and determine the procedure for awarding scholarships established by the President of the Republic Kazakhstan (hereinafter - the scholarship) to students of higher educational institutions, regardless of of subordination. the form ownership and departmental 2. The scholarship is aimed at: 1) stimulation of research and educational activities of students and undergraduates; support for the most talented and gifted students and undergraduates; 2) formation 3) assistance in the of intellectual potential. 3. The distribution of the number of scholarships between higher educational institutions is carried out in proportion to the contingent of full-time students of higher of Kazakhstan. educational institutions the Republic of 4. In higher educational institutions with a contingent of full-time students of less than 700 people, scholarships are not provided. 5. The scholarship is awarded to full-time students from the 3rd year and undergraduates from the second year of study, who study only "excellent" (A, A-), both on the basis of a state educational order, and on a paid basis. The scholarship is awarded to the following categories of students: 6. 1) winners of republican and international olympiads, creative competitions, sports competitions, festivals or who are the authors of discoveries, inventions; 2) having publications in collections of scientific papers, in republican and international scientific journals; 3) actively engaged in research work, the success of which is confirmed by diplomas, certificates. diplomas, certificates; 4) taking an active part in the social, cultural and sports life of educational organizations.

7. The appointment of a scholarship is carried out by order of the rector of a higher institution based on the decision Council. educational of the Academic 8. The scholarship is awarded for academic period. one 9. The scholarship may be repeatedly awarded to the same person in accordance with decision of the academic council of higher educational institutions. the 10. The decision of the academic council of a higher educational institution to award scholarships for the next academic period is made no later than two weeks before the start of the academic period and is sent to the Ministry of Education and Science of the

with list of Republic of Kazakhstan students and undergraduates. a 11. When awarding scholarships, the selection of applicants is carried out in the order of following the criteria set out in paragraphs 5, 6 of these Rules. Under equal conditions, the following have the advantage: without orphans and children left parental care; children disabled since childhood, with disabilities. 12. If a higher educational institution does not have applicants for scholarships that meet the criteria of paragraphs 5, 6 of these Rules, higher educational institutions, no later than two weeks before the start of the academic period, submit to the authorized body in the field of education information on the refusal of a certain number of scholarships

13. Scholarships are paid monthly within the funds provided in the republican budget for the corresponding financial year.
