9. Justification of the choice of discipline:

Compulsory medical insurance (CHI) is a type of compulsory social insurance, which is a system of legal, economic and organizational measures created by the state aimed at ensuring, upon the occurrence of an insured event, guarantees of free provision of medical care to the insured person at the expense of compulsory medical insurance funds within the territorial program of compulsory medical insurance and in cases established by Federal Law, within the framework of the basic compulsory health insurance program. Primary health care, including preventive care, and emergency medical care (with the exception of specialized (sanitary-aviation) emergency medical care) are provided within the framework of the basic program of compulsory medical insurance.
